- **JUNIOR CADET MEMBERS** of the Association are those members who are under the age of 18 years (by the last day of February in the year) and who have not yet passed the Preliminary Test of Ice Skating Australia Incorporated.
- **SENIOR MEMBERS** of the Association are those members who are aged 18 years or over (by the last day of February in the year) and who
  - have passed the Preliminary Test of Ice Skating Australia Incorporated or its equivalent; or
  - are the parent or spouse of a Junior or Senior member who has passed the Preliminary Test of Ice Skating Australia Incorporated or its equivalent.
- **ASSOCIATE MEMBERS** of the Association are over the age of 18 years and
  - are candidates for the Preliminary Test of Ice Skating Australia or its equivalent; or
  - seek to enter Association competitions or championships which do not require a test entry qualification
